TO WHOM DOES THIS WARRANTY APPLY? – The Company extends the following limited lifetime warranty to the original user only.

WHAT DOES THIS WARRANTY COVER AND HOW LONG DOES IT LAST?

LIMITED LIFETIME RAZOR WARRANTY – Certain Van Der Hagen razors, defined as razors with solid brass handles, are warranted against material manufacturing defects for the life of the Product for a period of five (5) years from the date of Product purchase. Products warranted against material manufacturing defects for a period of five (5) years from the date of Product purchase are referred to by the product numbers 400062, 401210, 401211, 401212, 401213, 401214, 401215, 401216, 401217, 401218, 401200, 401201, 401202, 401203, 401204, 401205, 401206, 401207, 401208 and 401209. The Company reserves the right to update this list.

WHAT THIS WARRANTY DOES NOT COVER – The Company will not be liable for any labor, transportation or consequential expenses not specifically stated above. There is **NO WARRANTY** in cases of damage in transit, negligence, abuse, abnormal usage, misuse, accidents, normal wear and tear, damage due to environmental or natural elements, failure to follow the Company's instructions, unauthorized repair, incorrectly performed maintenance or repair, improper installation or storage or use of acidic, abrasive cleaning materials.
